In consideration of being granted the opportunity to participate, I hereby agree to release and hold harmless STEAM Central, Stephens Central Library, Tom Green County Library System, Tom Green County, its employees, volunteers, committees and boards, from and against any and all liability, loss, damages, claims, or actions (including costs and attorney's fees) for bodily injury and/or property damage, to the extent permissible by law.

I hereby assume all of the risks of participating in any/all activities associated with STEAM Central at the Stephens Central Library, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

Any available insurance of the Maker's shall be primary and STEAM Central at the Stephens Central Library shall be Non Contributory.

I hereby give permission to STEAM Central at the Stephens Central Library for emergency transportation and/or treatment in the event of illness or injury and this release extends to any liability arising in connection with such transportation and/or treatment. I hereby accept responsibility for the payment of any emergency transportation and/or treatment. I further certify that I am in good physical condition, and have no medical or physical conditions that would restrict my participation in this activity or program.

I acknowledge that STEAM Central at the Stephens Central Library and its employees, volunteers, committees and boards are not responsible for the errors, omissions, acts, or failures to act of any party or entity conducting a specific activity on their behalf.
