
The probable cause for this filing of this complaint is that affiant is a peace officer under the laws of the State of Texas, employed by the San Angelo Police Department. Affiant has reviewed the offense reports and spoken with Det. Castro and Det. Dye and Det. Kolbe, and learned that a shooting had occurred on March 26, 2016 at 1145 East 22nd Street, San Angelo, Tom Green County, Texas. On March 31, 2016, in a mirandized audio/video recorded statement, Det. Castro interviewed Ramos. Ramos identified himself to Det. Castro. Affiant personally observed the interview and personally spoke with Det. Castro following the interview. Erick Ramos told of his involvement as the driver of the vehicle; Ramos advised that he was aware of the plan to shoot at Zane Lopez's residence. Ramos stated that he drove the vehicle into the alley behind the residence, stopped the vehicle, passengers got out of the vehicle; Ramos heard shots fired; passengers got back into the vehicle and Ramos drove all passengers away from the scene.

Det. Kolbe advised Affiant that Joe Lopez, the father of victim Zane Lopez told Det. Kolbe that Zane Lopez lived at 1145 East 22nd Street, San Angelo, Tom Green County, Texas.

Affiant has read the report of SAPD Officer Charles Barker; Officer Barker had been called out for shots fired on March 26, 2016, to 1145 East 22nd Street, San Angelo, Tom Green County, Texas and located two people, later identified as Juan Guerrero and Zane Lopez; each with





On March 31, 2016, in a mirandized audio/video recorded statement, Det. Castro interviewed Garcia, whom Det. Castro knows on sight. Affiant personally observed the interview and personally spoke with Det. Castro following the interview. Garcia told of his involvement as being in the suspect vehicle as a passenger and that he shot a black .40 caliber handgun toward the residence he knew to be Zane's house. Det. Kolbe advised Affiant that Joe Lopez, the father of victim Zane Lopez told Det. Kolbe that Zane Lopez lived at 1145 East 22nd Street, San Angelo, Tom Green County, Texas. Garcia stated that he knew of the plan to shoot at the house of Zane Lopez.

Affiant has read the report of SAPD Officer Charles Barker; Officer Barker had been called out for shots fired on March 26, 2016, to 1145 East 22nd Street, San Angelo, Tom Green County, Texas and located two people, later identified as Juan Guerrero and Zane Lopez; each with apparent gunshot wounds to the head. Castro and Det. Dye interviewed GILBERTO SALVADOR REYES; Det. Castro knows Reyes on sight. Affiant personally observed the interview and personally spoke with Det. Castro and Det. Dye following the interview. Affiant spoke with Det. Dye who told Affiant that Reyes advised Dye that he knew guns had been used in a homicide. Reyes told Det. Dye that he had taken possession of the guns and had concealed the guns from police.

Affiant spoke with Det. Dye who interviewed Juvenile #1 who advised Affiant that Reyes had given the green light on Zane Lopez. Affiant knows that a "green light" means that permission had been given to kill the targeted subject.

Affiant has read the report of SAPD Officer Charles Barker; Officer Barker had been called out for shots fired on March 26, 2016, to 1145 East 22nd Street, San Angelo, Tom Green County, Texas and located two people, later identified as Juan Guerrero and Zane Lopez; each with apparent gunshot wounds to the head. 




